In a letter to Godfrey, **MAWSS** Chairman **James Bell** said MAWSS is not responsible for delaying the project.

Bell also points out that the 98 bypass cannot open anyway until **the gap** connecting the new 98 to Highway 158 and ultimately to Interstate 65, something ALDOT says will take a few more years.

Godfrey wonders how many more drivers will be injured or killed before the project is completed, many of those accidents he's seen personally over the past 20 years.

James Williams Bell had served as the youth minister at **Mt. Tabor Baptist Church** for a year and a half before his January arrest.

Bell, 26, pleaded guilty Thursday to two counts of criminal sexual conduct with a minor in the second degree, four charges of a lewd act upon a child under 16 and contributing to the delinquency of a minor.

Bell said in court Thursday that he instigated sexual encounters in the church gym and at his condominium between April and November 2001. Four boys were involved in all the charges.

After one of the boys told his parents, **Bell** admitted to the church pastor and the Sheriff's Office that the allegations were true, said his attorney, Steve Haigler.

Bell told the judge he was remorseful and willing to continue counseling.

Assistant Solicitor Joy Davis was seeking a 25-year sentence for **Bell**.
